On June 8- 9 2018, Shastri Indo-Canadian Institute organized a conference titled "Engaging India and Canada: Challenges of Sustainable Development Goals" with support from MHRD, Government of India at India International Centre, New Delhi. The deliberations in the Conference focused on bridging two divides that constrain current SDG scholarship and discourse: one between individual countries such as Canada and India as they each address the challenges of the SDGs, as well as the divisions that separate academic disciplines and categories. The conference brought together members of the interdisciplinary network of SICI-affiliated researchers in Canada and India.

The conference also overcame the divisions between disciplinary and purely national approaches to sustainable development. Most importantly, the conference strengthened and

promoted Canadian and Indian scholarship, boosted bi-national networking, training and mentoring opportunities.

The Conference provided a platform for a new cadre of researchers from India and Canada to present their work and discuss further academic and institutional collaborations between Indian and Canadian universities and research institutes (For List of Participants refer Annexure 1 below).

The Inaugural Session began with the Vice-President/ President-Elect of Shastri Institute, Prof. Faizan Mustafa welcoming the participants from India and Canada and also the distinguished guests. Prof. Girish Shah, the President of Shastri Institute, highlighted the role of the Shastri Institute in working towards achieving Sustainable Development Goals. The Secretary Treasurer of Shastri Institute & Conference Coordinator, Prof. Anil Mehrotra gave an overview of the conference stating that the main objective of this conference was to consolidate and enhance the Canada and India research partnership in order to meet the challenges of Sustainable Development Goals. Prof. Mehrotra informed everyone that this year's theme relating to Sustainable Development was proposed by Prof. Margaret Walton-Roberts, who is a Member-at-Large of Shastri Institute's Executive Council. He further stated the theme areas of the conference - Community Well–Being, Reducing Inequalities, Improving Health, Sustainable Energy Development and Environmental Sustainability. He briefed the audience regarding the receipt of 273 abstracts from 114 institutions on eight themes of the conference, out of which 59 were selected for presentation at the conference. This was followed by a lamp lighting ceremony by all the dignitaries present at the dias.

His Excellency, Mr. Nadir Patel, High Commissioner of Canada to India in his inaugural address congratulated the Institute for celebrating its Golden Jubilee year and wished it continued success for the next fifty years. He said that SICI has done some amazing work in last five decades and plays an important role in also being ambassador for both Canada & India. In his address he highlighted the astronomical growth of Indian students in Canada over the last few years and stated that he would like to see more Canadian students in India as well through study tours, exchanges, modules and ultimately through joint degree/ dual degree programs. He also said that we need to expand the nature of educational relationship between Canada and India - there are more opportunity for greater Faculty Exchanges; train the trainer programs, executive education programmes tailored to different organizations, and he said that more can be done in capitalizing on the Alumni network in both the countries of Universities from both Countries. He further said that the Shastri Institute is the centre of promoting academic and cultural ties between India and Canada and is an important stakeholder in Higher Education Cooperation MoU between India and Canada.

After the Inaugural address, a publication of papers presented at the International Congress titled '**Etudes quebecoises en Inde et a l' etranger'** held on March 29-31, 2017 at Shimla by Dr. Shakti Kapoor, was launched. This publication was funded by Shastri Indo-Canadian Institute.

Dr. N. Saravana Kumar, Joint Secretary, Department of Higher Education, Ministry of Human Research Development gave the special address at the Conference. He congratulated Shastri Institute on successfully completing 50 years. He spoke about the main challenges of the Indian Educational System being skewed Educational progress of the country, Low

Employability in Education Sector, Research and Low Global Rankings of Indian Institutions. He highlighted on the new initiatives of Ministry of Human Resource Development in his address viz.Unnat Bharat Abhiyan, IMPRINT and Uchchtar Avishkar Yojna. He also spoke about the recent launch of 'Study in India' Program which promotes India as the study destination for foreign students from 30 countries presently. He also spoke about GIAN programme and the scheme for promotion of Research and Academic collaborations in about 25 countries. He concluded his address by committing MHRD's support for Shastri Institute.

Dr.Ashok K. Jain, Adviser (RD & SDGs), NITI Aayog gave the keynote address on challenges of sustainable development goals faced by India. He spoke of the seventeen SDG's and its 169 targets which is applicable to all the countries. He stated that NITI Aayog has been entrusted with responsibility of overseeing the implementation of SDG's in India and the Ministry of Statistics & Programme implementation was asked to monitor and evaluate how India is performing on these SDG's. The core principle for implementation of SDG's in India was the 'Collective Efforts and Inclusive Growth'. He talked about the mapping of programmes of all the ministries of Government of India to all the SDG's. He also spoke about the upcoming National Dashboard on SDG's which will display the progress made on each goal and live information shall keep flowing from all concerned. He further stated that all SDG's are interconnected and have universality. He spoke of India's targets for clean energy, housing, drinking water, proper sanitation, creation of carbon sink. He told that despite India being a country with a large population, we are going strong in achieving SDG's. He stated that capacity building and SDG financing were the key challenges for the implementation of SDG's. At the end he congratulated the Institute on completion of its fifty years. The Inaugural session, ended with a vote of thanks given by Dr.Prachi Kaul, Director, India Office.

After the Inaugural session there were twelve sessions held over the two days where papers were presented by fifty eight (58) presenters from both India and Canada. Four parallel sessions each were held from 11:15 am to 1:15 pm on 8th June 2018. The first parallel session on '**Community Well-Being**' was co-chaired by **Prof. Braj Sinha**, Department of Religious Studies and Culture, University of Saskatchewan and **Prof. Ravishankar Rao**, Department of English, Mangalore University and had five presentations. These were:

1. Engaging with Environment: Myth, Storytelling and Sustainability

2. Traditional Knowledge and Community Well-Being: Environmental Sustainability in North East India and Canada

3. A Cross-Cultural Comparison the Traditional Healing Practices in India and Canada 4. Biology, ideology, and the problem of patriarchy: Mahila Shanti Sena - a women's movement for self-driven empowerment and gender equality

5. Gender Inequality and Ill-Health: The Role of Caste and Class In Tamil Nadu

The second parallel session on **'Improving Health'** was co-chaired by **Prof. Pratima Tatke**, Department of Pharmaceutical Chemistry, SNDT Women's University and **Prof. Selvadurai Daya Dayanand**, Department of Biology, Concordia University and had four presentations:
