- 1. The recommended poster size is -A3
- Authors should mention their Name, Designation, Institution Name, Email id, and Contact details. In case of co-authors, designate a corresponding author for all official communication.
- The poster should include the following details viz, Introduction/Background, Statement of Problem, Research Methods, Research Objectives, Conclusion and Recommendations and key references/ Bibliography. Poster presentations are organised in poster sessions and will be held thematically.

In absentia or online paper/poster presentations shall not be encouraged.

All papers reviewed by the organising committee shall be peer-reviewed and only selected papers will be allowed for oral/poster presentation at the Conference.

The final list of paper presenters shall be uploaded to the University website. Selected papers in the conference shall be published as an edited book with ISBN number. Publication fee of Rs. 1,000/- will be charged additionally.

According to UNCTAD's report, the ocean economy is worth an estimated \$ 3-6 trillion. Albeit its huge benefits, the blue economy poses a big challenge to understanding the better management of oceanic sustainability, marine ecosystems and collaborations across the borders and sectors to protect, preserve and benefit the marine resources. The United Nations has also noted that the blue economy will aid in achieving the UN's Sustainable Development Goal 14, i.e., "life below water". Undeniably, the ocean protects biodiversity and absorbs 30% of the carbon dioxide emissions, maintaining a symbiotic balance between ecosystems. However, the concerns of overfishing, climate change, deep-sea mining, and coastal erosions due to unbridled development at coastal zones are alarming and need immediate attention. If unaddressed, it will result in the depletion of natural resources, especially in countries like India and Canada which have long coastal lines, marine biodiversity must create a sustainable blue economy. Canada's blue economy accounts for about \$31.65 billion annually in and it's the source for 30,000 canadian jobs and India's GDP has significantly increased to \$7.222 billion through blue economy's contribution.

The United Nations has observed that a blue economy will help in attaining SDG 14 by promoting trade, investment through innovation and sustainable living. The blue economy is portrayed as a means to achieve sustainable development. However, it requires strict policy regulations, institutional responsibilities, and regional and international cooperation which is primarily lacking in this area. This conference aims to initiate deliberations among scholars from Science. Social Sciences, Economics, Engineering Technology, Marine Biology and Law disciplines upon the existing biological, social, ethical and legal implications of the blue economy through sustainable consumption of marine living resources and the need for developing policy regulations and navigating institutional responsibilities in India and Canada to address the concerns. This conference will provide a platform for paper and poster presentations from all scientific, social and legal disciplines. A panel discussion will also be organised as part of the conference.
